Notes:

(1) Blended match rates (i.e., match rate by state fiscal year) assume 25% of expenditures occur in the last federal quarter which is the same as the state first quarter for the fiscal year indicated above. The formula used to calculate the blended match rate is:

$$(.25)(\text{previous year}) + (.75)(\text{current year}) = \text{match rate for state fiscal year}$$

i.e., FFP for Medicaid for state FY 1999: $(.25)(.5149) + (.75)(.5160) = 51.57$
i.e., FFP for CMSIP for state FY 1999: $(.25)(.6604) + (.75)(.6612) = 66.10$
