The principal assistant is the Deputy Director who assists the Director in all aspects of Medicaid planning, development, evaluation and the daily operation of all program functions, in addition to supervising the Support Services Unit.
- B. Consultant professional medical personnel are retained on a part-time basis to render advisory services for the Department staff. Qualified consultants are arranged, as needed, to assist in matters affecting podiatry, optometry, psychiatry, physician services, nursing home care, dental services, and screening and evaluation of children.
